

Annual Spring Business Meeting Monday, March 19, 2018 Samoset Resort, Rockport, ME

Minutes from Spring Business Meeting

Called meeting to order -1:00 p.m.

Steve thanked Past Presidents and Annual Conference Committee

Steve thanked Landscape Structures and ME O'Brien as key sponsors; Northeast Charter and Tour and Kompan; Musco Lighting; Funtown/Splashtown

Video Contest – Yarmouth Community Services; Skowhegan Outdoor Adventure Program; Windham Parks and Recreation; Houlton Parks and Recreation- winner was Houlton Parks and Recreation

Current Board members were recognized for their contributions; Steve encouraged participation by others for committee involvement

Secretary's Report: (Willette, MacNeil) – All in favor

Proposed Budget – Steve reported that we are in good financial shape – loss of Russell was very difficult for the membership due to his many years of contribution to the board; Deb Smith has stepped in to manage the treasurer's duties in his absence; Steven explained budget is fairly standard – a few minor changes, including the Russell Packett Scholarship Fund that will be continually funded separately; (Willett, Kaherl) – All in favor

Committee Reports:

<u>Student Reports:</u> (Andy) – Explained his personal MRPA goal of having more students attending the conferences; 6 students applied (most so far) with 4 recipients present due to the MRPA Scholarship; Some Board members have been speaking at local colleges (SMCC a few weeks ago; SJC on Wednesday)

<u>Spring Conference</u>: (Karyn) – Breaking records with attendance over-all; Karyn thanked delegates and vendors; thanked Nicole Welch as the speaker chair; Karyn recognized all of the conference committee members and for their roles; Karyn stressed the importance of delegates meeting with the vendors and the contributions that the vendors make, which enables us to keep our costs down.

<u>Scholarship</u>: (Steve) – Steve explained the MRPA Scholarship fund (separate from the Russell Packet Fund) – encouraged members to apply for this 2x/year opportunity and also encouraged people to take part in scholarship fundraisers

<u>Fall Workshop</u>: (Nicole) – Will begin working on this late March, and get it done before summer camp begins; encouraged people to bring forth topic ideas

<u>Track & Field</u>: (Tim) – New Balance and Northeast Charter and Tour will be sponsors; 3 regionals – 6/26. 2/27 an 6/28 – Regional tournaments; July 10 – State meet; Looking for volunteers at regional and state meets

<u>Pitch, Hit and Run</u>: (Tyler) – Event starts locally; Boys and Girls from 7-14; 3 Regionals to be held late May or early June; Winners move on to Fenway

<u>Golf Tournament:</u> (Steve) – Bill Bonneyman Tournament on September 7; money raised traditionally goes to Scholarship Fund; Last year, proceeds (approximately \$8000) went to Russell's family

<u>Ticket Program:</u> (Kate) – Summer consignment tickets – Funtown/Splashtown, Aquaboggen, York's Wild Animal Kingdom – Kate suggested vendors could offer this to employees as well; Kate welcomes other suggestions for regional venues; Information should be coming out in the next few weeks; Winter Program has not been as successful – Sunday River/Sugarloaf not willing to participate

<u>Hot Shot Program:</u> (Hillary and Andy) – Coordinated with Maine Red Claws with State competition at the Portland Expo; 20-25 communities participated this year; State Competition was yesterday with 33 participants; Andy thanked those communities that hosted the regional competitions; Also thanked Deb Smith and Joe Crocker for their assistance at the state competition; Andy's last year as co- coordinator

<u>NNERPC</u>: (Lisa) - January 8-10; Location changing to North Conway Grand Hotel – more rooms for on-site accommodations; vendor space is bigger; meetings to be held in June; Registration between August – October

Awards: (Tracy)- Thanked committee and those that nominated candidates

<u>Legislative</u>: (Tracy)- Discussed LWCF worries – up for reauthorization; RTP program is stable at this point;

Regional Updates:

EMPRA – Deb reports that there many more EMPRA members; invited vendors to come to quarterly meetings

SMART – Jen reported that the group is meeting fairly regularly; 30-40 people attended the Positive Coaches Alliance last month; hoping to do other trainings like that – next one planned for April; also encouraged topic ideas

NMCRA – Hillary reported that they continue to meet monthly; collaborate with school departments; thanked MPRA for funds for training

Membership (Deb): 32 agencies with 177 staff; 86 professional members; 7 associate members (parttime), 66 commercial; 6 retired; 30 student memberships; 1 friend for a total of 360 - 19 new members this year; says a lot about the organization

<u>Executive Director Report</u>: Deb shared goal accomplishments for the Board this year; Matt Tobin helped us with the 1st Field Maintenance Workshop; Positive Coaching Alliance; created Mentoring Program – 4 young professionals looking for a mentor; more professionals signed up to be mentors; 4 matches created today; Many sponsorships were fostered this year; Helped Ellsworth Maine create a Parks and Recreation Department as a response to a request from that town; Deb discussed the VIP Program – received two applications this year; Candidates keep track of how they participated – recipient gets the \$250 VIP Professional Development (Steve Balboni); \$100 VIP Recipient (Nicole Welch)
