  - c. Legislative Advocacy
    - i. Active Maine Lifestyle Expo Sabrina and Deb provided an update on the progress for the Active Maine Lifestyle Expo, tentatively scheduled for April 30 and May 1 in Auburn at the Norway Savings Bank Arena. Focus will be Maine Brands, organizations and non-profits celebrating all the contributing factors to keeping an Active Maine Lifestyle. Discission around commercial membership and to be aware of any budget impacts. Board supported moving forward with MRPA involvement.
    - ii. Flavors Hook Kids this initiative was defeated at the legislative level and they are regrouping.
    - MMA Deb sent out the circle chart that NRPA and MRPA have collaborated on and will be presenting at the MMA conference to help share 'why' parks and recreation is an essential service.
    - iv. Equality Maine Bill These bills did not pass in Maine.
  - d. Summer Camp Training Deb provided an update on the successful event and will explore any future needs.
  - e. Fall Workshop: Gary provided an update focusing on the programming and sessions and will have everything finalized by the beginning of September. The Fall Conference will be on October 15 at The Lewiston Armory. They are exploring the opportunity to stream the sessions to allow for virtual training.
